In consideration of the acceptance of my application for entry in the above event, I hereby freely agree to and make the following contractual representations and agreements.

1. I have executed the Entry Blank and Release Form provided by the event sponsor and I agree to be bound by its terms. This County of Marin Release of Liability is in addition and supplement to the Entry Blank and Release form, and shall not reduce or limit the obligations assumed by me by executing that Entry Blank and Release form.

2. I FULLY REALIZE THE DANGERS OF PARTICIPATING IN A BICYCLE RACE AND OTHER CYCLING ACTIVITIES ON PUBLIC ROADS OF THE COUNTY OF MARIN AND I VOLUNTARILY ASSUME ALL THE RISKS ASSOCIATED WITH SUCH PARTICIPATION. I agree that it is my sole responsibility to be familiar with the race course and the public roads over which the race will pass. I understand that the roadways of the race route are open to automobile traffic and may contain conditions such as uneven surfaces, lack of banking, narrow or no shoulders, weathered or lack of signing and striping, and rocks, gravel, sand, oil or other slippery substances.

I AGREE TO ASSUME ALL RISKS ASSOCIATED WITH RIDING ON THE PUBLIC ROADWAYS OF THE COURSE. I RELEASE, FOREVER DISCHARGE AND AGREE NOT TO SUE THE COUNTY OF MARIN FOR ANY AND ALL LIABILITY, CLAIMS, LOSS, COST OR EXPENSE, INCLUDING BUT NOT LIMITED TO INJURY TO MY BODY, MENTAL TRAUMA OR DEATH ARISING IN ANY MANNER, INCLUDING THE SOLE NEGLIGENCE OF THE COUNTY OF MARIN, AS A RESULT OF MY PARTICIPATION IN THIS EVENT.

3. I agree, for myself and my successors, that the above representations and agreements are contractually binding and are not mere recitals and shall bind me and my successors for the above event and all other associated events and activities on the public roads of the County of Marin. This agreement may not be modified orally and a waiver or invalidity of any provision shall not be construed as modifying any other provision herein or operate as a consent to any subsequent waiver or modification.

**I HAVE CAREFULLY READ THIS ENTRY AND RELEASE FORM AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THIS IS A RELEASE OF LIABILITY, A WAIVER OF CLAIMS, AN AGREEMENT NOT TO SUE, AND A CONTRACT BETWEEN MYSELF, AND THE PROMOTER, AND FOR THE BENEFIT OF OTHERS DESCRIBED HEREIN, AND I SIGN IT ON MY OWN FREE WILL.**
